It is hereby informed to all the candidates who have applied for the post of Technical Assistant, Post code no. TA20237 (NO. OF POSTS:02 [ST- 01 & OBC(NCL)-01]) in the area of B.Sc. Chemistry in response to this office Advt No. CSIR-CBRI 08/2023, the duly constituted Screening Committee under the provisions of "CSIR Service Rules, 1994, for Recruitment of Scientific, Technical and Support Staff" has scrutinized and shortlisted the applications by adopting the following criteria:-

- (i) Age, Application Fee and other conditions, as per advertisement.
- (ii) Minimum Qualification (with Division/Percentage of Marks) as per advertisement.
- (iii) Experience (with number of years from of the date acquiring the minimum qualifications level and specific areas, if any) as per advertisement.
