Notification to the Advt. No. CSIR-CBRI 05/2025

It is hereby informed to all the candidates who have applied for the post of Technician in the area of Computer/ITPost code no. T10-25 (NO. OF POST: 02 [UR -02]) in response to this office Advt No. CSIR-CBRI 05/2025, the duly constituted Screening Committee under the provisions of "CSIR Service Rules, 1994, for Recruitment of Scientific, Technical and Support Staff" has scrutinized and shortlisted the applications by adopting the following criteria:-

(i) Age, Application Fee and other conditions, as per advertisement.

(ii) Minimum Qualification (with Division/Percentage of Marks) as per advertisement.

SSC/10th Standard/SSC or equivalent with Science subjects, with minimum 55% marks and ITI Certificate or National/State trade Certificate of **Computer/IT** trade.

OR

SSC / 10th Standard or equivalent with Science subjects, with minimum 55% marks and 2 years full time experience as an apprentice trainee from a recognized Institution in **Computer/IT** trade.

OR

SSC/10th Standard or equivalent with Science subjects, with minimum 55% marks and 3 years of work experience in the **Computer/IT** trade in a Ministry/Department/Organization/ Public Sector Undertaking/Autonomous Body under Government of India /State / UT.

(iii) In order to ascertain 55% marks in SSC/10th Standard where there is grading system & conversion not provided in the online application, the information available on internet has been provisionally used to ascertain 55% marks for shortlisting. In case later it is found that conversion formula varies the calculation of marks will be made on actual formula.
