He possess a three-year Diploma in Architectural Assistantship, a qualification which is higher in level than the ITI trade certificate. The curriculum of this diploma includes comprehensive theoretical and practical training in architectural drafting, building construction, materials, quantity estimation, and CAD-based design, which are core competencies expected for the post of Draftsman (Civil/Architecture). 2. The subjects and training undertaken in his diploma are equivalent or superior in content and rigor to those in the ITI Draftsman (Civil) syllabus. he is confident that his academic preparation fully meets the requirements for the technical duties expected under this role, including CAD-based drafting, estimation, and supervision. 3.
