(i) Age, Application Fee and other conditions, as per advertisement.

(ii) Minimum Qualification (with Division/Percentage of Marks) as per advertisement.

SSC/10th Standard/SSC or equivalent with Science subjects, with minimum 55% marks and ITI Certificate or National/State trade Certificate of **Electrician** trade.

OR

SSC / 10th Standard or equivalent with Science subjects, with minimum 55% marks and 2 years full time experience as an apprentice trainee from a recognized Institution in **Electrician** trade.

OR

SSC/10th Standard or equivalent with Science subjects, with minimum 55% marks and 3 years of work experience in the **Electrician** trade in a Ministry/Department/Organization/ Public Sector Undertaking/Autonomous Body under Government of India /State / UT.

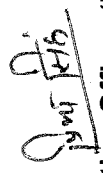
