**Sub: Notification of Result for recruitment to the post of Technician (Pay Level -2)
CSIR-CBRI Advertisement No. CSIR-CBRI-5/2025**

1. Notification for filling up **17** vacancies of Technician, against **11 Post Codes** was issued vide CSIR-CBRI advertisement No CSIR-CBRI – 5/2025 reg. However, due to lack of the competition in Medical Lab Technician (Post Code -T09-25) and Digital Photography (Post Code-T11-25), the said posts will be re-advertised on due course of time as notified vide even No. dated 18.06.2025.
2. Total **768** online application were received against **17** vacancies. Out of **768** total **613** candidates were shortlisted for appearing in Trade Test. The final list of shortlisted candidates was issued vide notification of even number dated 23.06.2025.
3. Trade Tests were conducted at Chandigarh from 28.06.2025 to 29.06.2025. Total **194** candidates appeared for the Trade Test. Total **180** candidates were declared qualified in Trade Test as notified vide CSIR-CBRI notification of even number dated 01.07.2025.
4. The Written examination was conducted on 27.07.2025 at Roorkee. **161** candidates out of **180** appeared in Written Examination. There were three papers (Paper-I, Paper-II & Paper III) for written examination. As per advertisement and selection process for these posts Paper-I is qualifying in nature. Final merit list has drawn on the basis of the marks obtained by the candidates in Paper-II and Paper-III.
5. The selection committees which met on 31.07.2025 and 01.08.2025, fixed the following threshold marks in **Paper-I** (for **09** post codes) for evaluation of Paper-II and Paper-III in respect of all posts.


