Sub: Notification of Result for recruitment to the post of JSA(Gen./F&A/S&P) Pay Level – 2 vide Advertisement No. CSIR-CBRI-02/2025

All the candidates appeared for written examination on 18.05.2025 for the post of JSA(Gen./F&A/S&P), Post code JSA252 vide advertisement no. CSIR-CBRI-02/2025 are informed as under:-

1. Total 4511 online application were received against 16 vacancies. Out of 4511 total 4256 candidates were shortlisted for appearing in Typing Test. The list of shortlisted candidates was issued vide notification of even number dated 17.04.2025.
2. Typing Test were conducted at Roorkee from 26.04.2025 to 30.04.2025. Total 857 candidates appeared for the Typing Test. Total 105 candidates were declared qualified in Typing Test as notified vide CSIR notification of even number dated 05.05.2025.
3. The Written examination was conducted on 18.05.2025 at Roorkee. Out of 105 total 98 candidates appeared in Written Examination. There were two papers (paper-1 & paper II) for written examination. As per advertisement and selection process for these posts paper-II was evaluated only for those candidates who secured the minimum threshold marks (determined by the Selection Committee). Final merit list has been drawn on the basis of the marks obtained by the candidates in Paper-II.
4. The selection committee which met on 16.05.2025 fixed the following threshold marks in Paper-I & Paper II for evaluation.


