**Engagement of Part-time Doctor (Allopathic System) at CSIR –CBRI, Roorkee**

The Central Building Research Institute (CBRI), Roorkee, is a constituent unit of Council of Scientific and Industrial Research (CSIR), New Delhi is a premiere Institute in the area of Building Science & Technology and has been vested with the responsibility of generating, cultivating and promoting building science and technology. CSIR-CBRI carries out applied and basic research in various areas of building science and technology to provide S&T backup to the problems related to Shelter Planning, Building Materials, Structure & Foundation and Disaster Mitigation. R&D is being pursued to develop new Building Materials and Construction Technologies and to transfer the developed technologies to the industry for commercialization.

CSIR-CBRI desires to engage Part-time (purely on temporary basis) at CSIR-CBRI, Roorkee on payment of a monthly consolidated honorarium for OPD treatment of its employees, pensioners, family pensioners, their dependent and project staff. <b>Emoluments.</b> Part-Time Doctor will be paid honorarium @ Rs. 46,020/- per month for performing three hours duty per day on all days (except Sunday and Holidays)						

**Job requirement and Honorarium:** To perform general duties as a Part-Time Medical Officer at CSIR-CBRI, Roorkee and to attend the patients which will comprise employees, pensioners, their dependent, family members, family pensioners and project staff. In case of serious ailments, if required, he/ she has to refer patients to any of the Hospital which are empanelled with CSIR-CBRI, Roorkee for extending treatment with credit facility or without credit facility as the case may be.

### General Terms and conditions:

1. The date for determining age/ qualification and experience shall be the date of the **Walk-in-Interview**.
2. No TA/ DA will be paid to the candidates for attending the walk-in interview or for joining, if selected.
3. The above position is purely temporary on Contract basis for one (01) year. Candidate engaged in this position will not have any right implicit or explicit for consideration for regularization/ absorption against any post (s) of CSIR-CBRI, Roorkee.
4. **Leave:** The Part-time Doctor would not be entitled for any kind of regular leave. However, he/she will be entitled for 08 days leave in a calendar year, to be calculated on pro-rata basis.
5. **Confidentiality of data, information and documents:** The information, data and documents related to the patients shall remain confidential. No one shall utilize or publish or disclose to a third party, any part of the data or statistics or proceedings or information collected for the purpose of this assignment or during the course of assignment for the office, without the express written consent of the office. The Part-time Doctor is bound to hand over the entire set of records to the office before the expiry of the contract.
6. **Conflict of Interest:** The Part-time Doctor engaged by this office, shall not represent or give opinion or advice to others in any matter which is averse to the interest of this office.
7. Canvassing in any form and/ or bringing any political influence or otherwise will be treated as a disqualification for the above position.
8. **Termination of Service:** The engagement may be terminated at any time by the office without assigning any reasons by giving a notice of 30 days. In case, a part time medical officer desires to leave the contract/job, he/she has to serve the notice before 30 days which can be curtailed/extended at the discretion of the Appointing Authority.
9. The income Tax or any other tax liability will be as per the prevailing rules and it will be deducted at source before effecting the payment of honorarium for which the office will issue TDS certificate.
10. Eligible candidates must bring with them all original requisite documents viz. Date of Birth, Educational Qualifications (MBBS Degree and all other qualifications), Experience (s) and PPO (in case retired from service) etc., at the time of Walk-in-Interview. In case of failure to bring the original certificate, candidates will not be allowed to appear for the interview.
11. The engagement of Part-time Doctor is subject to the terms and conditions issued by CSIR in this regard from time to time. For all intent and purposes, the services of part time medical officer will be under administrative control of the Director, CSIR-CBRI, Roorkee.
12. The decision of the Director, CSIR-CBRI, Roorkee in all matters relating to eligibility, acceptance or rejection of applications and mode of selection will be final and binding on the candidates.
13. The Candidates applying for above position must be medically fit.

### Procedure for Engagement of Part-time Doctor:

1. Before filling up the application form in the prescribed application format (**Annexure A**), candidates are advised to check their eligibility as per the advertisement.
2. Candidates are advised to report for selection process at **CSIR-CBRI, Roorkee First Floor Conference Room** at **09:30 AM on 30 June 2026**. **Documents verification will be carried out prior to the selection process.**
3. Candidates are required to report for Interview on the said date, time and venue alongwith application form duly filled with photocopies of necessary certificates and **original documents**. Candidates reporting after reported time will not be allowed.
4. The selection process will start from **11:00 AM onwards on 30 June 2026** and can be extended to the next day in case all the candidates appearing for selection process could not be assessed on the same day.
5. The Part-Time Doctor will be selected based on their performance in the Interview.

6. Candidates are advised to make their arrangements for stay and travel accordingly. No assistance will be provided by CSIR in this regard.
7. The venue, date and time of selection process may change due to administrative reasons. If so, the same will be notified on CSIR-CBRI Website. Candidates are advised to check CSIR Website regularly for updates regarding this.
8. Candidates are required to bring original of all their testimonials, educational qualification certificates at the time of selection process. They will not be allowed for Interview without production of original documents.
9. The Part Time Doctor to be engaged as indicated above is provisional.
10. The decision of the Director, CSIR-CBRI in all matters relating to eligibility, acceptance or rejection of application, mode of selection, not to fill up all or any of the Part-Time Doctor will be final and binding on the candidates and no interim inquiry or correspondence will be entertained in this connection from any individual or his/ her agency.
